CULTURAL SAFETY - MAORI

POLICY STATEMENT

It is Bay of Plenty District Health Board's (BOPDHB) policy that patients / clients who identify as Māori have their health and disability needs met in a manner that respects and acknowledges their individual values and beliefs.

BOPDHB recognises and has a commitment to the Treaty of Waitangi and Crown principles of partnership, participation, protection and equity, He Pou Oranga Tangata Whenua framework as endorsed by Te Runanga Hauora Māori o Te Moana a Toi (the Runanga) and Mai nga kuri a Wharei ki Tihirau Kahui Kaumatua council.

PURPOSE

- To assist staff in understanding the meaning of the Treaty of Waitangi and its significance in relation to Māori Health.
- To ensure policies and services are consistent with the Treaty of Waitangi principles.
- To have engaged in consultation with whānau, hapū, Iwi and Māori health providers in the interests of defining a Tangata Whenua view of Hauora (health and wellbeing) and Haumate (Unwellness) that can be applied to inform future health strategy for Māori in the Te Moana a Toi.
- To provide health services which are culturally appropriate and delivered in a culturally safe manner.
- To improve and advance Māori Health status and outcomes and to achieve Māori Health gain by reducing health inequalities for Māori in a way that is consistent with national priorities and Māori aspirations (refer 'He Korowai Oranga – The Māori Health Strategy', Ministry of Health, 2014).
