POLICY STATEMENT

It is Bay of Plenty District Health Board's (BOPDHB) aim that CPR is carried out effectively and appropriately within its facilities.

PURPOSE

This policy defines standards regarding CPR and the decision making process on whether to provide CPR or not to particular patients – refer to 6.3.7 protocol 0.

- Section A sets out the standards for CPR.
- Section B sets out the standards required if either the patient or medical practitioner(s) do not consider CPR to be in the patient's best interest.
